



HK LEISURE MARINE INDUSTRY OVERVIEW *STRONG MARITIME CULTURE*



Once a fishing village, Hong Kong (HK) has rapidly developed into one of Asia's busiest ports. As Asia's World City backed with a strong economy, HK provided plenty of opportunity for the leisure boating industry to grow. Since the late eighties, water sports has massively gained in popularity and more of the wider population are participating in all types of water sports especially those involving boats under sail or motor. From 1999 onwards, the number of registered pleasure vessels has constantly increased an indication the industry is growing. Today, HK has positioned itself as the top leisure marine industry in the Asia Region. China has indicated that they are learning from the HK Leisure Marine Industry for future development in the mainland. HK plays a key role in the Greater Bay Area Yacht Industry development and in the Asia region.



The HKBIA is the source for accurate government clarification that affect the leisure boating industry.

Clarification on Group Gathering Restrictions for Class IV Vessels:

In summary from the Food & Health Bureau and Ince & Co advice (Prior to confirmation from F&H Bureau):

Privately owned Class IV vessels are classified as "private spaces". As they are not "public spaces", the group gathering regulation (Cap. 599G) does not apply.

Class IV Charter Boats that are hired for social gatherings are classified as "Party Rooms". Therefore under Cap. 599F Schedule 2, are required to be suspended till 28 July 2020





As for Kwun Tong Typhoon Shelter, we understand that it is still required for providing shelter for local vessels under inclement weather, and serving as the home base for different types of local vessels during normal days. This may limit the possibility for designating part of it solely for mooring of leisure boats. We trust that the Marine Department would provide their views on this aspect. On your suggestion in paragraph 8.2 of the report to develop all manner of water sports and water-based recreational activities, it is in line with our commitment to introducing and facilitating more water-friendly activities in Hong Kong. For instance, we have facilitated some water sports associations in their applications for sites fronting Kwun Tong Typhoon Shelter to provide land-based supporting facilities. You may also be interested in the Government's proposal for the development of a water sports complex at the rehabilitated Shek O Quarry site. For details, you could refer to the paper submitted to the Southern District Council on 8 July 2021 which is available on the District Council's website.



Summary

This paper seeks to introduce multiple measures to reduce the immediate environmental impact in the build and operation of leisure marine vessels.

The Low Impact Boating Initiative (LIBI) is a new framework to address areas in which the world wide leisure marine industry, from paddle boards to Superyachts, can work together to reduce the environmental impact of our industry.

There is an overwhelming scientific consensus that human activity is raising world temperatures, leading to unsettled climatic conditions and the potential for catastrophic rising sea levels on a world wide scale.

Our energy intensive lifestyles, increasingly adopted worldwide, are working against our ability to reduce greenhouse gas emissions and pollutants.

Where consumer campaigns around the world have had a huge impact on other industries - from plastic straw manufacturers to cars - our industry has failed to keep up with the changing commercial and regulatory environment outlined in the Appendix to this paper.

In general the Leisure Marine Industry has been a receiver, not an initiator, of environmental regulations mostly mostly generated by National authorities. Few initiatives to address these issues have come from us as an industry.

While commercial maritime has been adopting increasingly strict criteria for build and operation of new and existing vessels, in comparison the leisure marine industry on a worldwide scale is still looking for exemptions on fuel use, exemptions on emissions, and much of the fleet is constructed out of materials which are impossible to recycle except with high energy inputs.

The Low Impact Boating Initiative seeks to rectify that deficit. We need to be leaders, not just followers, or we are in danger of received regulations putting our entire industry's existence in question.














The old Shek O quarry basin is no longer used as a tunnel building area and could be used as a water sports centre. The land area required for a water sports centre is already in place as is an access road. 


Wan Chai Basin- Potential for Marina with Water Sports Facility






Sai Kung Typhoon Shelter – Potential for expansion



Re: Hong Kong Boating Industry Association - Industry Report

Thank you for your letter of 19 July 2021 to the Secretary for Development and the Industry Report attached to the letter. We have coordinated with the Invigorating Island South Office (IISO) and would like to reply to you on behalf of the Secretary.

Your report covering the current state and needs of the leisure boating industry in Hong Kong is informative and insightful. Thank you for sharing the report with us. There are issues falling under the purview of the Marine Department, and we understand that you have also sent the report to the Department.

As announced in the 2020 Policy Address, one of the key projects under the Invigorating Island South initiative is to explore the expansion of the Aberdeen Typhoon Shelter area and the vessel berthing area as well as providing more land facilities. IISO is working closely with the Civil Engineering and Development Department in studying the technical feasibility of expanding Aberdeen South Typhoon Shelter with a view to commencing the investigation and preliminary design of the project as soon as possible. IISO also collaborates with relevant government departments in providing additional landing facilities and formulating proposal for developing a waterfront open space in Ap Lei Chau, including possible incorporation of a dragon boat storage area to promote water-friendly culture.

As for Kwun Tong Typhoon Shelter, we understand that it is still required for providing shelter for local vessels under inclement weather, and serving as the home base for different types of local vessels during normal days. This may limit the possibility for designating part of it solely for mooring of leisure boats. We trust that the Marine Department would provide their views on this aspect. On your suggestion in paragraph 8.2 of the report to develop all manner of water sports and water-based recreational activities, it is in line with our commitment to introducing and facilitating more water-friendly activities in Hong Kong. For instance, we have facilitated some water sports associations in their applications for sites fronting Kwun Tong Typhoon Shelter to provide land-based supporting facilities. You may also be interested in the Government's proposal for the development of a water sports complex at the rehabilitated Shek O Quarry site. For details, you could refer to the paper submitted to the Southern District Council on 8 July 2021 which is available on the District Council's website.



THE IMPACT OF Covid-19 AND AVAILABLE GOVERNMENT RELIEF MEASURES FOR THE LEISURE MARINE INDUSTRY

Introduction:

Hong Kong's economy has experienced decelerating growth since Q2 2018 with the full year for 2019 contracting by 1.2% year on year (y.o.y.). This was a result of sharp contractions in Q3 and Q4 of 2019 (-2.8 and -2.9% y.o.y. respectively). Whilst US-China trade disputes and a general economic downturn may have been to blame for the earlier decline, the fall in the second half of 2019 is due to the social and political unrest we have experienced. Corporate bankruptcies surged from 10.498 in October 2019 to 14,394 in November 2019. What looked like a calmer and hopeful start to 2020 was then hit hard from Chinese New Year onwards by the ongoing impact of the Covid-19. A double whammy.

China has been Hong Kong's largest trading partner since 1985 with 50.4% of HK trade being with China in 2018. Hong Kong was the Mainland's fourth largest trading partner (after the US, Japan and Korea) in 2018, and Hong Kong was the Mainland's second largest export market, taking up 12.2% of its total exports in 2018. With Covid-19, the interruptions to the supply chain, office and factory closures, travel and quarantine restrictions and cessation of normal trade with China has affected many

In Hong Kong, the effect of this virus and the social and political reaction to it has been devastating both for social welfare and for business confidence and activity. Hong Kongers still have strong memories of the effects of SARS in 2003, and it may be their hygiene precautions as a result which have helped to limit the spread in HK. But such social isolation and limitations are not economically sustainable. Prolonged uncertainty. China trade difficulties, restrictions in local and international travel, event cancellation, staffing issues due to travel bans, guarantine, home work and school closures, combined with a lack of trust in the current government's ability to deal with the situation has resulted in dramatic drops in economic activity. Hong Kong exports dropped 22.7% in Jan20 y.o.y., the unemployment rate increased from 3.3% in the 3 month to Dec 19 to 3.4% in the 3 months to Jan20 (source: tradingeconomics.com)

Whilst Government and media attention has focused on the impact of plummeting tourist numbers, retail sales and other indicators on the retail, transport, tourist and hospitality industries, there has been a severe impact on all businesses in Hong Kong. It has left those not targeted by government relief schemes feeling left out and the Leisure Marine Industry certainly falls in to that category. Even the \$10,000 handout to all permanent HK ID holders will come too late to be of benefit now, when it is actually needed -Financial Secretary Paul Chan seems to think the guickest they can do it is "by the end of the summer"

Casual discussions with some industry members has indicated significant falls in turnover in the past couple of months, some far in excess of 50% down whilst still facing the same rent and staff cost liabilities. Most companies have private not government landlords and therefore can argue but are unlikely to get a reduction in rent. Hong Kong landlords are notoriously difficult.

So the aim of this report is to highlight the relief measures that are in place and may be applicable to HKBIA members. It is by no way complete and not all measures may apply, but hopefully it will highlight some relevant measures that may be of use to your business. Am in the NY area but throughout the US the emphasis is on discouraging and cancelling group activities and implemented sanitary hygiene and deep cleaning.

Many business have gone to remote access where feasible

Companies and Governments are being encouraged not to penalize people who are ill and requesting them to stay home in voluntary or other quarantine for 2 weeks

For marinas and boating – prudence should be the first priority. Many recreational area are implementing deep cleaning and for employees and users the use of gloves, hand sanitizers and keeping hands away from face and other body parts.

We will know a lot more about the virus and how it is spread over the next few weeks and therefor what other measures may wish to be considered.

But the current thinking is it will get a low worse before it gets better and proactive approaches are most important





Here goes the current situation in Portugal:

There are no special/new measures for visiting yachts and regarding the Corona virus crisis. The government did not declare the country guarantine. There is a clear and abrupt slowdown in Tourism in general, mainly big cities and business/event travels. Marinas are still keeping the same occupancy rates but there is a much lower inflow of reservations and a lot less boats traveling along the coast. There are contacts made to marinas to enquire about extending stays that were initially planned for six to nine months, which means the clients are considering changing their crusing plans and not wanting or delaying travels.

Most of the events in Marinas have been cancelled until the end of May and until a more clear vision exists. Events from June onwards are on hold.

We are very worried about small nautical businesses that work using the marinas as their basis: charter businesses, sailing schools, diving companies, bars, restaurants, etc. Most of them are small family businesses that cannot survive after 4 to 5 months of no income. Obviously this will impact the industry and our Marina businesses as well.

Hi All,

In Hong Kong we had the problems earlier than elsewhere. Basically all boat shows in Asia were cancelled. International Dinghy and School competition events in HK were cancelled. The Rolex China Sea was cancelled due to the 14 days quarantine the boats would have had to undertake when they arrived in the Philippines.

With the Government not allowing their staff to return to work after the Lunar New Year holiday, and the shutting down of China, many local business were also not at work. This saw an increase in people using their boats, but with less people on board. With the schools being closed there is a greater demand for children orientated sailing courses, sail training and adventure on the water courses.

Yacht Clubs and Marinas are still busy with members using their boats but Food and Beverage is taking a hit.

We, at the Royal Hong Kong Yacht Club, have drawn up contingency plans for if we have to close one of our Clubhouses for two weeks, for deep cleaning and compulsory home quarantine of all staff, due to a person with a confirmed case of the virus having used the Club facilities.

We did have a case but the person in question only walked through the car park and on to a sampan to get to and from their boat. As the person did not go inside any facility of the Club we did not close down. However we advised the sampan operator to quarantine for two weeks and we arranged for the sampan to be deep cleaned.





BOAT SHOWS – A SHOWCASE TO THE WORLD

Boat Shows have always been an integral part of the leisure boating industry – everyone in the industry knows the Southampton Boat Show in the UK, Boot Dusseldorf in Germany, Fort Lauderdale in the USA, METS in Amsterdam. They have become both a local and International draw and boost for their country and local markets. The strength of these shows is that they are open to and represent ALL sectors of the leisure marine industry. With the breadth of the market, services and expertise, Hong Kong could also put itself on the map in a similar way with a fully fledged boat show. Whilst there have been small privately run shows in the past, none have proven to be fully accessible for all in the industry due to cost constraints. These limitations have resulted in small shows with little international draw. HKBIA are working towards finding a solution.

With the expertise of the industry coupled with the pristine coastline, Hong Kong has the potential to become the leisure boating and nautical tourism hub of the Greater Bay Area and beyond.
